<u>Mr. McCourt (Fairborn)</u> – The High School building process is almost done; Spring sports and clubs are going well; The new athletic facility is starting to take shape; The students and the community are excited for the district.

Mrs. Gillaugh (Cedar Cliff) – Future Farmers of America held their banquet on March 21st; There will be a Kindergarten parent meeting on April 23rd; Open Enrollment starts May 13th; Prom is this Saturday, April 13th; The next regular board meeting has been rescheduled to, Tuesday, May 21st.

Mr. Taylor (Beavercreek) – The High School Bowling team finished first in the state; The Junior ROTC unit placed 1st in their competitions; The Spring play is "The School of Rock"; The district has high hopes concerning the community forum that is being held on April 11th; A Senior Citizen luncheon is April 23rd with the band, show choir and JROTC involved; He was very impressed with the Mock Prom.

Mr. Leightenheimer (Xenia) – Construction at Warner Middle School is under budget and ahead of schedule; The high school is doing an update to their cafeteria; Shawnee Elementary has received the Momentum Award for the second time; Prom will be held April 27th; K-12 enrollment opened on April 1st; The outdoor learning lab is breaking ground this month; Todd Whalen is the new principal at the high school.

Mr. McQueen (Yellow Springs) – Black History Month was observed in the elementary with a project where they connected with alumni; 1st graders were able to explore some of Ohio's snakes last month; E-Sports is doing very well in the middle and high school; 21 members were inducted into the National Honor Society.

Mrs. Arthur (Greeneview) – The annual PTO Carnival raised thousands of dollars; The juniors completed their ACT testing on March 13th; Kindergarten registration is underway; The Future Farmers of America held their banquet; The spring musical is "Beauty

and the Beast."; Conversation on ESSER money was held; There are several open positions for teachers and coaches; Spring sports are going well; State testing is taking place this month.

Mr. Remaly (Bellbrook) - The district Art Show will be on Saturday, April 13th; The PTO introduced a new donation campaign, called Fill the Nest; Prom will be held on April 27th; The 4th annual Music Boosters Mattress Sale will be held on April 28th; Graduation will be on Saturday, May 18th.

<u>Administrators</u>

Brian McKnight (Director of Secondary Education) – Starting the hiring process for new 2024-2025 staff; The district is heavy into the competition and testing season; Will have students presenting at National competitions; The next Salon Day is April 13th; The last Salon Day will be held on May 4th, along with a Car Show; National Technical Honor Society induction will be held tomorrow night.

<u>Georgia Lewis (Treasurer)</u> - Next week will be attending the OASBO Annual Conference; This past week completed the three hour long Public Records training as the district designee.

<u>David Deskins (Superintendent)</u> – GCCC was highlighted in two articles in the local paper about their outreach to elementary students in the county; The building experienced a water leak late last week. Jason Alexander was recognized for his help with this event; A meeting was held with Lt. Governor Hustead concerning the Workforce Initiative and the need for \$1.2 million in funding for equipment; A proposal was made to Senator Hackett requesting \$18 million for the Public Safety Initiative; The district is hopeful to receive a grant for \$107,000 for the virtual reality equipment in their adult education program.

<u>Adult Ed</u> - All graduating cadets passed the state test; Recruiting for Sept 2024 is ongoing; Corrections Academy started on March 12th. 12 officers are currently enrolled; Probation training was given on March 11th. 10 Officers were in attendance. More training is scheduled for April; Animal Welfare Officer training is scheduled in April.
