- Mr. Uecker (Fairborn): Building projects continue; A Fairborn Board member attended Open House; Attended Capital Conference.
- Mrs. Reagan (Greeneview): Still waiting on playground equipment; Play was held last weekend and was a success; Was re-elected to the Board.
- Mr. Taylor (Beavercreek): Attended Capital Conference, found it not well attended; Took part in Title IX session. Found it to be like sipping from a firehose; Opening for a football coach following his resignation after a perfect season, no wins; Faith Leaders Conference was held. Bi-annual meeting with Clergy and school leaders to discuss matters of joint concern; New Board member, Carl Fischer, replaces retiring Denny Morrison.
- Mrs. Martindale (Cedar Cliff): Year is going fast; Four ran for 3 seats, two incumbents were re-elected. She did not run; New appointment to GCCC will be Matt Sheridan; Happy with Open House and all the attendees from the community with no direct student connection in attendance; Expressed her thanks to the Board, Superintendent and Treasurer. Has enjoyed her time on the GCCC Board and has been able to see so much accomplished.

Administrators

- Ginny Potter (Assistant Superintendent): Update on Leadership Focus groups; Seeing an increase in public customers for Cosmetology and Culinary following the Open House; Attended ACCSC required renewal conference held in Richmond, Virginia at the end of October for the Adult Education accreditation.
- Ron Bolender (Public Information Officer): Been in contact with nearby Legacy Village to take advantage of Culinary and Cosmetology on days they are open to the public; Working on recruiting; Open House is planned for January.
- Eva Anderson (Treasurer) – Treasurer's office is busy prepping for year-end; The upcoming software migration; And preparing for office staff extended absences.
- David Deskins (Superintendent): Commended staff on their work with the focus teams. These teams align with the strategic goals; Open House/Dedication night was well attended with much positive feedback; Planning negotiations with the certified staff for February; Admin staff are participating in a book study exploring grading; Update on Employability Skills and interest by other entities emulating GCCC.

Adult Education Updates

- Basic Peace Officer Academy started on September 20, 2021. We currently have 24 students enrolled. Xenia PD, Wilmington PD, Beavercreek PD, Centerville PD, and Miamisburg PD are each sending one cadet.
- Many of the cadets volunteered for the Drug Takeback on October 23rd.
- Corrections Academy started on October 12th. We currently have 22 Corrections Officers enrolled.
- We had two training dates for Probation Officers in October with another scheduled in November.
- We hosted our Greene County Law Enforcement Advisory meeting on October 21st with 20 in attendance.
- The December Basic Peace Officer Academy starts on December 6th. We currently have 11 enrolled but have more scheduled to sign up this month. One is being sent by Wilmington PD.
- Commander Hild announced his retirement at the end of this school year.
