### WHAT IS WORK-BASED LEARNING

Greene County Career Center works closely with the business community to develop job opportunities for students enrolled in career-technical programs.

Work-Based Learning (WBL) is a combined effort of career-technical teacher, student, and business. It is recommended that each student participate in multiple venues of WBL experiences to facilitate transition from school to the world of work.

### WHO IS ELIGIBLE

Students who participate in off-site WBL must meet multiple criteria and demonstrate strong professional skills. Participation in an off-campus work program is a privilege, not a right. Students enrolled in these programs will be evaluated by the business, the instructor, and our WBL Coordinator or other school officials. At any time, a student can be taken off work placement for any reason by any party involved. Students must apply and be evaluated by the WBL Coordinator prior to being part of an off-campus work program.

**PARENT/GUARDIAN AND STUDENT SIGN A STUDENT APPRENTICESHIP AWARENESS CONTRACT.**



**LAB AND ADMINISTRATION APPROVAL**

IF A STUDENT RECEIVES A FAILING GRADE FOR THE QUARTER, PLACEMENT STATUS WILL BE REVIEWED BY THE STUDENT'S TEACHERS AND ADMINISTRATION.

## JOB SITE PLACEMENT AND INTERNSHIP

- Paid or unpaid position
- Student-Employer-Instructor agreement on workload according to state standards.
- Advancement of student skills
- Off-site work environment during or after school

## PRE-APPRENTICESHIP PROGRAM

- Cooperative venture between the Bureau of Apprenticeship and Training, Apprentice Ohio, the Ohio Department of Education Office of Career and Technical Education, and the WBL Coordinator at the Greene County Career Center.
- Work-based preparation for formal registered apprenticeship training programs.
- Apprentices must be at least 16 years old.

## SCHOOL BASED ENTERPRISE

- Student co-ops a single business or service in his/her concentration.
- The school may provide facilities, input, resources, and equipment.
- Partnership agreements define roles, responsibilities, and profit distribution.
- Hours should not include time the student is receiving direct classroom instruction.
- The student, teacher and mentor must co-plan the experience strategically.

## REMOTE OR VIRTUAL PLACEMENT

- The student often works outside the business setting during or after school hours.
- Paid or nonpaid
- Student performs the skills or competencies determined necessary for the operation of a business
- Student development is provided in relation to the Career Field Technical Content Standards.
