- Mr. Remaly (Bellbrook-Sugarcreek) Great participation at the last school board meeting regarding masking. K-6 are currently all masked, with the upper grades optional.
- Dr. Callahan (Xenia) High participation at next school board meeting is anticipated with the recent mandatory masking requirement; Moving forward with the building process; Football team having a successful year.
- Mr. Uecker (Fairborn) Expressed appreciation for Brett Doudican obtaining the TIES/STEM grant; Also to Mr. Deskins and Mrs. Anderson for the completion of the building project. Appreciation was also expressed to Shook Touchstone for providing a fair offer in resolving the remaining issues and providing GCCC with a good value with their construction; Fairborn is also facing masking issues.
- Mr. Taylor (Beavercreek) A lot of administrative energy is going into the masking issues; Popcorn festival this weekend; Required to shut down 2 jobs last month due to the owners having COVID.
- Mr. McQueen (Yellow Springs) 3 Members to be replaced on the school board, including himself; Levy is the hot topic in the community; Sports are going well; School has no reported COVID cases, but watching closely after the recent outbreak at the Children's Center.
- Mrs. Reagan (Greeneview) Meeting next week; Currently mandatory masking; 2 weeks ago 20% of students were absent due to positive COVID tests and quarantine; New superintendent doing an incredible job.
- Administrators
  - Eva Anderson (Treasurer) Full-time assistant to start on Monday; Audit on-going; Career-Tech State Budget meeting being rescheduled.
  - David Deskins (Superintendent) COVID update- full masking due to high absence rate; Exemptions offered for medical, religious and special education reasons. Several parental complaints. School may not quarantine students, but rather may exclude students; Reminder of Building Dedication November 4 from 4:00 7:00 p.m.; Planning to replace a vacant clerical support staff position; Continue to evaluate the recruitment position recently vacated by Janet Baughn; Overview of Strategic Focus Targets for 2021-2024.
  - Rob Robison (Director) Working on COVID hybrid plans to keep as many students in school as possible.
  - Ginny Potter (Assistant Superintendent) Overview of District Leadership Teams.
- Adult Education Updates
  - The next Basic Peace Officer Academy will start on September 20, 2021. We currently have 26 students enrolled. Xenia PD, Wilmington PD, Beavercreek PD, Centerville PD, and Miamisburg PD are each sending one cadet.
